



NATIONAL PARK FOUNDATION'S FIND YOUR PARK EXPEDITION CONTEST OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION PERIOD:** The National Park Foundation's "Find Your Park Expedition" Contest (the "Contest") begins at 12:00:01pm Eastern Time ("ET") on July 11, 2016 and ends at 4:59:59pm ET on August 5, 2016 ET. The National Park Foundation's (the "Sponsor's") computer is the official time keeping device for the Contest.

ELIGIBILITY: The Find Your Park Expedition (the "**Contest**"), sponsored by the National Park Foundation ("**Sponsor**"), is open only to legal residents of the fifty (50) United States, the District of Columbia, Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa and the Northern Mariana Islands who as of the date of entry are twenty one (21) years of age or older. No purchase is necessary, and there is no fee to enter or to win the Contest. Employees of Sponsor, the National Park Service or any of Sponsor's advertising or promotion agencies, and members of the household (whether related or not) of any such current employee, and any person or entity engaged by Sponsor to participate in the promotion of the Contest and the employees and representatives of any such person or entity, and members of the household (whether related or not) of any such employees and representatives are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law or regulation.

3. **HOW TO ENTER:** During the Contest period, submit your entry by visiting www.nationalparks.org, and completing all required information and click "Submit". Incomplete applications will not be considered. Please submit a photo in .jpeg format along with your application.

LIMIT: One (1) submission per Individual is permitted during the Contest period. Multiple entries for participants are not allowed. Any attempt by a participant to submit more than one (1) entry during the Contest period by using numerous email addresses, registrations, identities, or any other methods will void that participant's entries and that participant may be disqualified. Valid entries must contain all information requested. Incomplete and/or multiple entries will be disqualified. In the event of a dispute, the authorized account holder of the email address used to enter will be deemed to be the participant. The authorized account holder is the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. Contest winner(s) will be selected through a committee that includes NPF Find Your Park Expedition corporate sponsors and employees of the National Park Foundation. Eight individuals will be selected. The Sponsor will not verify receipt of entries. By entering, participants acknowledge compliance with the Official Rules, including eligibility requirements. Responsibility for receipt of entry rests solely with the participant.

- PRIZE DRAWINGS: The selection of NPF Find Your Park Expedition participants will occur between August 8
 and August 29, 2016. The final selection of participants will be announced publicly in September. Winner(s)
 agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions are final on all
 matters relating to this Contest.
- 2. **PRIZES:** The NPF Find Your Park Expedition package will include the following items:
 - (1) Southwest Airlines roundtrip tickets
 - (1) Gear and apparel from Retail Sponsors
 - Lodging (one room) for 9 days/8 nights split between an Aramark resort at Yosemite National Park and a
 yet to be determined hotel in San Francisco. Winner may be required to share a room with fellow
 participants.
 - Transportation from airport to San Francisco hotel at start of trip and then from Yosemite National
 Park to airport at close of trip. Winners may be required to drive provided rental cars. Valid driver's
 license required for all applications. Any other add-ons and transportation costs are the
 responsibility of the winner.
- 3. NOTIFICATION: Winner(s) will be notified by email within a day of the selection. Sponsor is not responsible for



any change of email address of participants. If a winner cannot be contacted from the information provided on the online entry form, the Sponsor reserves the right to select another winner within two days (48 hours) at its sole discretion.

- **DELIVERY DISCLAIMER:** The Sponsor disclaims all liability for the inability of a participant to complete an online entry due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond their control, or otherwise. The Sponsor disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by electronic transmission or other delivery method. The Sponsor is not responsible for human, mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: any form of active or passive filtering, insufficient space in participant's e-mail account to receive e-mail messages, failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet, or on any website, or lost or unavailable network connections which may limit an online participant's ability to participate in the Contest, and any injury or damage to participant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Contest. No mechanically reproduced entries or facsimiles will be accepted. Entries are void if incomplete, defective, altered, forged, illegible, or received outside authorized channels. Sponsor reserves the right at its sole discretion, to disqualify any individual (and all of his or her entries, or any portion thereof) who tampers with the entry process. Sponsor reserves the right, in its sole discretion to cancel or suspend this Contest should fraud, virus, bugs or other causes beyond the control of Sponsor corrupt the administration, security or proper play of the Contest. In the event of cancellation, Sponsor will determine winners in an equitable manner as determined by Sponsor.
- 5. **PUBLICITY; USE OF PERSONAL INFORMATION:** By participating, unless prohibited by law, all participants and winner(s) grant the Sponsor; Recreational Equipment, Inc.; Aramark; Columbia Sportswear Company, Subaru of America, LifeStraw, Southwest Airlines; and any other contest entity selected by the Sponsor (collectively, "Contest Entities"), along with the Contest Entities' respective subsidiaries and affiliated companies, divisions, parent companies, officers, directors, agents and advertising agencies permission to use their names, biographical information, characters, photographs, voices, videotape, and/or likenesses in connection with promotion of this and other Contest in any and all media now known or hereinafter invented without territorial or time limitations and waive any claims to compensation, royalty, right, or remuneration for such use. By participating in the Contest, unless prohibited by law, participants agree that the Contest Entities may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.
- 6. CONDUCT AND DECISIONS: By participating in the Contest, participants agree to be bound by the decisions of Sponsor personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Sponsor will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest. The Sponsor's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Sponsor, the Sponsor reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Sponsor deems appropriate. All decisions will be made by the Sponsor and are final. The Sponsor may waive any of these rules in its sole discretion. Any attempt by a participant or any other individual to deliberately circumvent, disrupt, damage or undermine the legitimate operation of this Contest is a violation of criminal and civil laws. Should such an attempt be made, the Sponsor reserves the right to seek civil and/or criminal prosecution and/or damages from any such person to the fullest extent permitted by law.
- 7. **MISCELLANEOUS:** The Sponsor may substitute prizes, as well as extend, modify, or discontinue the Contest at any time without prior notice. The Sponsor disclaims any responsibility to notify participants of any aspect related to the conduct of the Contest. The Sponsor is not responsible for any typographical error in the printing of these Official Rules, administration of the Contest or in the announcement of the Contest prizes. All entries and information become property of the Sponsor and will not be returned.

- 9. **JURISDICTION:** By entering, participants agree that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the District of Columbia without giving effect to any choice of law or conflict of law rules. By entering, participants consent to the jurisdiction and venue of the federal, district, and local courts located in the District of Columbia.
